 - b. S & S Septic Hauling Request for the City to receive septic for treatment/ Update/ Procedure/ separate work session? There are three options we could go with. Also need to consider, location, labor, capital cost and revenue. Council to discuss further a work session scheduled for February 7th at 6pm.

Norton Development/ The Cottages- Athens Street 19 units Plat Status/Approval by Mayor approved for 19 units, plat is under review, attorney noted the plat meets all the zoning requirements, next would be to submit building plans that would also have to meet zoning requirements, they would need to submit easements and all setbacks would have to followed. If they wanted to modify anything the applicant would have to resubmit a new application. Louie Hickman asked if the city had looked at other options for this property, more towards commercial usage. Felton Woods asked if the city could put stipulations near the underpass. Matt Hamby noted as long as the applicant meets the requirements, the city could not put stipulations on them.
- b. Hudson River Request for Variance form 365 Corridor / Overlay/ Mountain View Development/ Public Comment Heard /Request to table to January 2022 Garnett Smith/Gene Bramlett approved
- c. **NEW-**Proposed Annexation and Rezoning by Cook Communities /6492 7th St/ Lewallen 30.27 Acres from Ag to PRD Planned Residential Development, 90 proposed lots/ <u>Hall Co Gov Response to annexation</u>, before establishing schedule to be heard. Requires the city to send Hall County notice of annexation and they were supposed to respond by the 13th. We have not heard back. This will go before the planning commission.
